



Obtaining Your Concealed Carry Permit for Nevada

Once you have earned a certificate of completion, there are a few more steps to obtain your permit to carry in Nevada. This document will cover resident and non-resident applications, the materials you will need, where and how to apply, state reciprocity, and links to Nevada laws and guidelines.

Is a Concealed Carry Permit Required in Nevada?

Nevada is a “shall issue” state. Permits for residents must be applied for in your county of residence. Open carry is legal without a permit. In order to be eligible to apply for a Nevada concealed carry permit, you must:

- Be at least twenty-one or eighteen if you are in the military.
- Have successfully passed a firearms safety training course approved by the sheriff of the state. The firearm safety course must be one offered by a federal, state or local law enforcement agency, community college, university or national organization that certifies instructors in firearm safety. The course must include instruction in the use of handguns and in the laws of this Nevada.
- A resident of Nevada. Non-residents may also apply for non-resident permits.
- Be an American citizen
- You have not been convicted of certain misdemeanors within the last ten years, including stalking, violation of an order of protection, sexual assault and public indecency.
- Not a felon, a fugitive, a drug addict, have never been adjudicated mentally ill or committed, not an illegal alien, nor have been convicted of a misdemeanor crime of domestic violence.
- Your permit will be denied or revoked if you fail to meet the above requirements or at least one of the following is true:
 1. You have an outstanding arrest warrant.
 2. You have been declared incompetent/insane or have been have been admitted to a mental health facility within the last 5 years.
 3. You have been convicted of DUI within the last five years or committed to rehab for drugs or alcohol within the last five years.
 4. You have been convicted of a violent misdemeanor within the last three years or are a



felon.

5. You have been convicted of domestic violence or have a restraining order against you due to domestic violence.
6. You are on parole or probation or you have a suspended felony against you within the last five years.
7. You made a false statement on your application.

Documents Needed

- Completed, signed, and notarized application form. Do not sign until you are in the sheriff's office of your county of residence.
- Certificate of successful completion of firearms training certificate approved by the state.
- Current Nevada driver's license, military card, or Nevada-issued photo ID.
- Proof of citizenship (e.g., passport, birth certificate, certificate of citizenship from immigration authorities, or a current or expired U.S. passport).

State Reciprocity

Obtaining a concealed carry permit allows you to every day carry a concealed weapon in Nevada. The Nevada resident's concealed carry permit is honored in these states:

Alabama, Alaska, Arizona, Arkansas, Florida, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, West Virginia, Wisconsin, Wyoming.

Non-resident Nevada concealed carry permits are honored in these states:

Alabama, Alaska, Arizona, Arkansas, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Minnesota, Mississippi, Missouri, Montana, Nebraska, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, West Virginia, Wisconsin, Wyoming.

Resident and Non-Resident Application

Some states have different requirements and guidelines for Resident and non-resident concealed carry permits. In Nevada, both residents and non-residents may obtain Nevada concealed carry permits.



Residents

Concealed weapons permits are processed at the state level by the Nevada State Police. Residents must apply to the county office in which they reside.

1. Complete a weapons safety and training course in person or online at a Nebraska-approved facility or website.
2. Obtain a certificate of completion of a firearms training course.
3. Pick up a Nebraska Handgun Permit application at your local sheriff's office.
4. Fill out the two-page application form
5. Call your local sheriff's office to schedule an appointment
6. Present the application and necessary documentation **in person** to your local sheriff's office.
7. Include the following documents with your application:
 - Completed, signed, and notarized application form. Sign in front of the local sheriff.
 - Certificate of successful completion of firearms training certificate
 - Current Nevada driver's license, military card, or Nevada-issued photo ID.
 - Proof of citizenship (e.g., passport, birth certificate, certificate of citizenship from immigration authorities, or a current or expired U.S. passport).
 - The Nevada concealed carry permit is valid for five years. Include a check or money order for \$96.25 for a new permit or \$61.25 for a renewal
 - Processing time is under 120 days.

Non-Residents

Nevada residents can apply for a Nevada non-resident concealed carry permit. They can also apply for the Virginia Non-resident Concealed Handgun Permit to qualify for their CCW training. Nevada.

Nevada also recognizes concealed carry permits from these states:

Alaska, Arizona, Arkansas, Florida, Idaho, Illinois, Kansas, Kentucky, Louisiana, Massachusetts, Michigan, Minnesota, Mississippi, Montana, Nebraska, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, Wisconsin, and Wyoming.
